All families of Baltimore County Public School students adversely affected by the partial federal government shutdown may apply for meal benefits through our Free and Reduced-Price Meal Benefits Program. As changes in household size and income occur throughout the school year, eligibility can change; therefore, please visit the BCPS Web site for further information. To obtain a hard copy of the Household Meal Benefit Application (HMBA), contact your child's school or call the Office of Food and Nutrition Services (OFNS) at 443-809-7860. Applications will be processed within 24 to 48 hours.

Attached you will find the BCPS Resource/Support Services list and Resource List for Baltimore County Children and Families. These important resources outline some of the services available to our families. In addition, attached is a list of BCPS food pantries located throughout Baltimore County. Families are encouraged to take advantage of the resources that are available through BCPS and throughout the county.
